LETTER OF AUTHORIZATION A

TO MOVE OVERSIZE/OVERWEIGHT VEHICLE AND/OR LOAD OR MOBILE HOME

This letter grants authority to the above listed company to operate upon roadways under the jurisdiction of the City of Tucson, an oversize/overweight vehicle or vehicle and load, or a mobile home, with a valid permit from another Arizona jurisdiction in which the movement originated. State of Arizona (ADOT) permits will be honored for direct access to and from state or interstate highways; the route used MUST include a state or interstate highway.

THE PERMIT FROM THE OTHER ARIZONA JURISDICTION AND THIS LETTER OF AUTHORIZATION OR A COPY THEREOF, MUST BE POSSESSION OF THE VEHICLE OPERATOR AT ALL TIMES WHILE MOVEMENT OCCURS ON PUBLIC ROADWAYS WITHIN THE CITY OF TUCSON. THIS LETTER SHALL BE DISPLAYED UPON DEMAND OF A PEACE OFFICER OR AUTHORIZED AGENT OF THE CITY OF TUCSON.

GENERAL RESTRICTIONS:

1. The company name on this letter of authorization must be the same as the company on the permit issued by another Arizona jurisdiction.
2. This authorization is not valid for oversize vehicles or vehicles and load that exceed 120 feet in length, 20 feet in width, or 16 feet in height. Contact the Tucson Police Department at (520) 791-4440, 8:00 a.m. to 5:00 p.m. Monday-Friday, for routing restrictions and information.
3. All movement of oversize/overweight vehicles and load must comply with the restrictions on the reverse side of this letter of authorization.

ALL MOVEMENT OF OVERSIZE/OVERWEIGHT VEHICLES AND/OR LOADS, OR MOBILE HOMES, THAT ORIGINATE IN THE CITY OF TUCSON MUST BE AUTHORIZED BY A VALID OVERSIZE/OVERWEIGHT, OR MOBILE HOME, PERMIT FROM THE TUCSON POLICE DEPARTMENT.

ANY MATERIAL ALTERATION OF THIS LETTER OR AUTORIZATION SHALL CAUSE THE SAME TO BE NULL AND VOID. MECHANICAL REPRODUCTION IS AUTHORIZED. THIS LETTER MAY BE REVOKED AND CONFISCATED AT ANY TIME THE USER IS IN VIOLATION OF THE RESTRICTIONS LISTED HEREIN OR ANY PROVISIONS OF TUCSON CITY CODE, CHAPTER 20, SECTIONS 15, 15.1 AND 16.
