Residential High-Efficiency Toilet (HET) Rebate Policy Updates

Tucson Water is updating rebate program policies to maximize water savings and encourage customers to consider additional ways to save water.

Rebate Policy changes will go into effect July 1, 2022. Any fixtures purchased on or after this date will be subject to the updated policies.

A new type of toilet available to consumers is known as **Premium High-Efficiency Toilets**, which are rated by MaP (Maximum Performance). These Premium HETs must be WaterSense certified, flush no more than 1.1 gallons and receive high flush performance scores. \$100 Premium HET rebates will now be available for homes and buildings constructed through 2010 to achieve more water savings in an additional 30 years of housing stock that likely have 1.6-gpf toilets and may be reaching the end of their useful life. Single-family households, maximum 2 Premium HETs per property. Multifamily maximum, 2 Premium HETs per unit.

Residential High-Efficiency Clothes Washer Rebate Policy Updates

Tucson Water is updating rebate program policies to maximize water savings and encourage customers to consider additional ways to save water.

Rebate Policy changes will go into effect July 1, 2022. Any fixtures purchased on or after this date will be subject to the updated policies.

Tucson Water has found significantly different savings for customers replacing front loading and top loading machines through the Clothes Washer Rebate. Replacement of a top-loading washer with a qualifying front-loading washer yielded an 85% water savings, while replacement of an older front-loading washer with a qualifying front-loading washer only saved 15%. Policy changes are being made to account for the discrepancy in savings. Single-family households are eligible for one clothes washer rebate per customer. Multifamily customers qualify for a customized rebate on clothes washers.

<p>\$200 rebate for single-family residential customers for purchase and installation of a high-efficiency clothes washer on Consortium for Energy Efficiency (CEE) Qualifying Product List. One per customer.</p>	<p>\$200 rebate for customers replacing a top-loading washer with a washer on the CEE list; Required proof of this replacement (<i>invoice, photo, and old model number required</i>)</p>
	<p>\$100 rebate for customers replacing a front-loading washer with a washer on the CEE list (<i>invoice required</i>)</p>
	<p>\$100 rebate for new customers not replacing a clothes washer and purchasing a washer on the CEE list (<i>invoice required</i>)</p>
	<p>One rebate per customer. Rebate will not exceed the price paid for the clothes washer.</p>
